84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies that he / she has just and reasonable grounds to believe that the heretofore named defendant did commit the violation as stated above and the factual basis for belief is as follows:

On 8/25/16 your affiant (Inv Sam Bell) with the Bay County Sheriff Office Criminal Investigations Division states the listed defendant (Shannon Lamaree) did commit the offense of child neglect against [REDACTED] in which the state of Florida will act as the victim to wit;

Shannon and her boyfriend (Jonathan Nation) are the mother and father of [REDACTED]. On 8/25/16 Jonathan and Shannon brought their son to Bay Medical as [REDACTED] was not acting normally and appeared to be having serious health issues. Upon testing it was confirmed [REDACTED] was testing positive for methamphetamine.

Post miranda Jonathan admitted he and Shannon have been using methamphetamine at the residence and used on 8/25/16. A search warrant was performed on the residence and meth paraphernalia was found in the kitchen, mater bedroom, and master bathroom of the residence. Much of the meth paraphernalia was in plain site and in common areas.

...METH SPOON USED FOR CHILD MEDS...

Investigators spoke to Jonathan again after the search of the residence at which time Jonathan admitted to shooting meth on 8/25/16. Jonathan put the spoon used to hold the meth on the kitchen sink. Shannon advised she did give [REDACTED] medication, which was by the sink, using a spoon from the sink.

Based on this information that Jonathan and Shannon are the parents of [REDACTED]. The three of them reside in the residence where drugs and paraphernalia are in common areas that can be easily accessible and seen. Jonathan and Lamarre's negligence caused [REDACTED] to be subjected to methamphetamine, and their actions, or lack thereof, resulted in the ingestion of methamphetamine by [REDACTED]. I believe there is probable cause to show child neglect.
