


**COUNT II:** Brandi Buchholz, on February 14, 2016, in the County of BAY and State of Florida, did unlawfully draw, make, utter, issue or deliver a check or its equivalent to another, to wit: **Treasure Island Bingo**, in the amount of **\$100.00** or its equivalent, knowing at the time of the drawing, making, uttering, issuing or delivering of such check, or its equivalent, that there were not sufficient funds on deposit or credit with such bank or depository with which to pay the same on presentation, contrary to Florida Statute 832.05(2).
