84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies that he / she has just and reasonable grounds to believe that the heretofore named defendant did commit the violation as stated above and the factual basis for belief is as follows:

On August 29, 2016 on Collins Road in Bay County, Florida, your Affiant states that the defendant, Cody Allen Weber, did intentionally strike his live in girlfriend, against the will of said girlfriend, by stomping on her chest with his foot during an argument. The Defendant was highly irate and began walking off from the scene yelling loudly. Your Affiant drove up to Defendant and placed Defendant under arrest. After being placed into a patrol car belonging to the Bay County Sheriff's Office, the Defendant began beating his head into the window, then leaned back and kicked out the rear driver's side passenger window, causing approximately \$100.00 in damage. The Defendant then began attempting to break out the other side patrol car window, and while your Affiant was attempting to prevent the Defendant from doing so, the Defendant kicked your Affiant, a sworn, uniformed deputy with the Bay County Sheriff's Office, on your Affiant's left thigh with Defendant's foot. Due to aforementioned facts your Affiant does believe the Defendant is in violation of Florida State Statute 784.03, domestic battery, Florida State Statute ~~843.02~~, criminal mischief, and Florida State Statute 784.07, battery on a law enforcement officer.

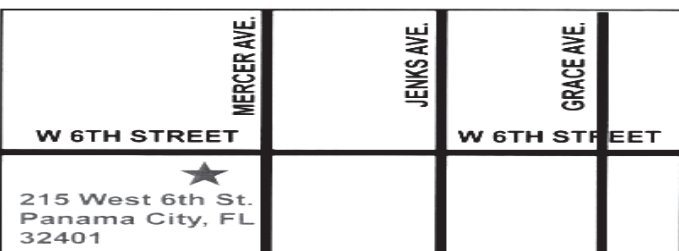
